## II. Fellowship Overview

Founded on the belief that Minnesota thrives when its artists thrive, the McKnight Foundation's arts program is one of the oldest and largest of its kind in the country. Support for individual working Minnesota artists has been a cornerstone of the program since it began in 1981. The McKnight Artist Fellowships Program provides annual, unrestricted cash awards to outstanding mid-career Minnesota artists in 14 different creative disciplines. Program partner organizations administer the fellowships and structure them to respond to the unique challenges of different disciplines. Currently the foundation contributes about \$1.7 million per year to its statewide fellowships. For more information, visit [mcknight.org/artistfellowships](http://mcknight.org/artistfellowships).

The McKnight Fellowship for Book Artists supports the conviction that the arts cannot flourish or enhance community life without the ideas, energy, and drive of individual artists, and that artists cannot make these contributions without unfettered creative time.

The goal of the McKnight Fellowship for Book Artists program is to identify talented Minnesota based book artists whose work is of exceptional artistic merit and who are at a career stage that is beyond emerging. The fellowship program supports two established artists per year by providing significant financial assistance, creating opportunities to meet with local and national art professionals, organizing a panel featuring the fellows and invited critics, and working with the fellows to create an individualized professional development plan.

The MCBA-administered fellowship program utilizes an independent jury of three arts professionals to competitively award two fellowships. The fellowships run for one year, from **August 2021 – July 2022** and include:

- \$25,000 (unrestricted) Fellowship funding to allow artists to set aside time for study, reflection, opportunities, new projects, experimentation, and exploration. Awards are subject to state and federal tax guidelines.
- Two studio visits with a selected art critic/curator/arts professional.
- \$2,000 travel stipend to attend a book arts conference such as CODEX, College Book Art Association (CBAA), New York Art Book Fair, etc.
- Opportunity to participate in a public panel discussion with selected national artist or critic in the field to develop a dialogue related to their art practice.
- \$1000 to spend on a custom tutorial with an established artist/practitioner in the field.
- \$750 to spend on documentation support (website development, photography, video)
- MCBA Artist Collective membership during fellowship year and year after fellowship, which grants unlimited access to MCBA's letterpress, papermaking, and bookbinding studios and equipment.
- Opportunity to attend an artist residency within two years of fellowship program.

### III. Application Process

**Jury Panel:** A three-member panel consisting of experienced and well-respected arts professionals selects the McKnight Book Art Fellows. The jurors are curators, artists (within the book arts field), directors, art critics, and educators with an appreciation for and knowledge of diverse aesthetic perspectives and contemporary art practices. All panelists are from outside the state of Minnesota. Panelists, insofar as possible, will represent a diversity of ages, ethnicity, gender, and geography. The McKnight Book Arts Fellowship panelists remain anonymous during the selection process. The names of the panelists are revealed once the fellowship recipients are announced.

**Review Process:** Applicants are evaluated and selected based on the quality of their work as evidenced in submitted materials, with most importance given to work samples. Consideration is given to accomplishments to date as well as promise for continued development and the impact the fellowship will have on the artist. The panel will also be asked to consider the breadth of artistic practices among Minnesota artists, which include a wide range of media, aesthetics, and traditions that might be influenced by ethnicity, gender, and geography.

**First Round:** The jury panel reviews submissions in the form of digital images viewed remotely on their own monitor for the first round. The jury panel will score each applicant numerically. In a conference call, the three panelists will discuss the top applicants to determine which applicants will move on to the next round. (Please note that juror monitors are not calibrated). Applicants will be notified of application status on **Friday, April 16, 2021**.

**Second Round:** Those applicants receiving the greatest interest will be contacted to schedule studio visits by the jury panel.

**Studio Visits for Finalists:** The Artist Program Director will notify the artists identified for final review by **Friday, April 16, 2021**. Jurors will conduct studio visits between **Saturday, May 1 & Sunday, May 2, 2021**. The Director of Artist Programs will work with any finalist whose studio is outside the Twin Cities to make alternative arrangements to meet the jurors.

**Notification:** Upon completion of the studio visits, the Director of Artist Programs will contact the two fellowship recipients and email the other finalists of the juror's final decision by **Friday, May 7, 2021**.

*MCBA staff who oversee the McKnight Fellowship program do not contribute to the decision-making process or the selection of the McKnight Book Arts Fellows. The role of the staff is to provide clarity for the review process and to ensure that the panel review and discussion proceed in accordance with the program's guidelines.*

## IV. Eligibility Requirements

*Applicants who do not meet all of the following criteria and expectations will not be considered and should not apply.*

The intent of this program is to recognize and support mid-career artists living and working in Minnesota who demonstrate a sustained level of accomplishment, commitment, and artistic excellence. Artists who are eligible for this fellowships:

- Create work that falls within a book arts context. Book arts is a family of processes that includes but is not limited to letterpress printing, screen printing, intaglio, bookbinding, box-making, papermaking, or paper decoration. Book art, broadly defined, includes work that embodies narrative, instruction, reference, mapping, guides, documentation, and more. It is work that engages the viewer and propels the experience forward through narrative, sequencing, spatial elements, visual or verbal language, temporal, mechanical, aural, typographic, symbolic or material means. As an interdisciplinary art form, book arts may include other mediums such as photography, other forms of printmaking, installation, sculpture, and film.
- Are at least 18 years old and a resident of Minnesota, as determined by voting and/or payment of taxes in the state. Applicant must also have a street mailing address within Minnesota to be eligible to apply.
- Have lived in the state of Minnesota at minimum the twelve months prior to the application deadline and will live in Minnesota for the duration of the fellowship period.
- Be able to provide evidence of professional achievements, such as inclusion in regional or national museum and gallery exhibitions and receipt of other awards, grants, and fellowships.
- Have at least eight years of professional experience, preferably in group and/or solo shows. *Exhibitions undertaken as part of a degree-seeking program at an institution of higher learning will not be considered, i.e. senior or thesis exhibitions, juried student shows, etc.*
- Demonstrate a sustained level of accomplishment, commitment, and excellence in their work.
- Be willing to participate in all aspects of the fellowship program, including meetings, studio visits by art critics, and a public panel with visiting critics.

### Applicants may not:

- Submit works in which the only means of expression is theatre-based performance, ceramics, printmaking, fiber arts, film, or video (exclusively). - Be enrolled in a degree-seeking program, either part-time or full-time, at an institution of higher learning.
- Have received a McKnight Fellowship in any discipline less than five years ago (here defined as from the beginning of previous fellowship year to current application deadline). Anyone who received a fellowship in any discipline in or before **2016** is eligible to apply.
- Apply to more than one of the McKnight Fellowships programs in a given year. Doing so will disqualify applicants from consideration in any program in that fellowship year. For example, if you applied to the McKnight Printmaking Fellowship at Highpoint for the 2021 cycle, you will not be eligible to apply for the McKnight Fellowships for Book Arts at MCBA.
- Work as staff or board or be an immediate family member of staff or board of the McKnight Foundation.
- Work as staff or board, or be an immediate family member of staff or board at Minnesota Center for Book Arts.

### Applying as a Collaborative Team

While McKnight Fellowships for Book Arts are traditionally awarded to individual artists, we recognize that there are many contemporary artists who work as collaborative teams. If you are applying as a collaborative, make sure each artist involved meets the eligibility requirements. The images you submit should be of work created by the collaborative, not by the artists individually. Please include one résumé for the collaborative, plus one résumé for each of its members, in a single multi-page document. Do not use your names, rather, distinguish between the résumés by using generic titles, such as, “Artists A and B,” “Artist A,” and “Artist B.”

## V. Application Instructions

**Application Deadline: Monday, March 1, 2021, Noon (12:00PM CST)**

*Late or incomplete applications will not be accepted.*

**Organize your application materials.** We strongly recommend that you assemble all of the application components in advance. Please keep your name off of all application materials (an artist signature on the work is acceptable).

**Create an account for your online application with Submittable:** On the MCBA Submittable page, which contains information about Submittable, click “submit” next to the McKnight Fellowship for Book Artists form. Scroll down to the bottom of the page to create a Submittable account or to log in if you already have an account. To create your account, you will need to provide your email address, a password, and your first and last names. Once you create your account, you will be directed to the “McKnight Fellowships for Book Arts Application” page. To enter the McKnight Fellowship application, click “Continue.” If you already have an account, once you sign in you will be taken directly to the application. *If you have any issues logging into Submittable, please contact their customer service directly.*

**Complete your application:** Fill out your contact information. Upload your application materials. You can “Save” your application and log out of your account to edit it at another time. Before submitting, you must agree to the Terms of Use. When you are ready to submit, click the “Apply” button. Once you have submitted your application, you will no longer be able to edit. You will receive a confirmation email soon after your application is received.

**All applications must include the following:**

1. **Contact Information Form.** *\*Required fields will be marked with an asterisk\**
2. **Proof of MN residency:** Applicant must have maintained MN residency for at least one year prior to application deadline (**March 2020**). Please upload a copy of one of the following: MN driver’s license (or MN identification card); a utility bill in applicant’s name; lease; tribal ID; or other supporting documents.
3. **Résumé:** Submit a current résumé that highlights your professional accomplishments and achievements, including exhibitions, awards, and grants. Do not include your name, home or studio address, phone number or e-mail address on the résumé. Label and upload your resume like this: Resume.PDF
4. **Ten Image Samples:** Applicants must include clear and professional image samples that have been made within the last 10 years. You may include full and detail shots, but each file counts as one of the ten total images. Upload images in the order you would like them to be viewed. Each juror reviews applications individually, one image at a time, on a personal computer monitor. Omit your name from each image (artist signature on the work is acceptable).

Image Specifications:

Images must be in JPEG or JPG format, 300 DPI, 1200 pixels or greater on the largest side.

Individual file should not exceed 5 MB.

Label each artwork: Image\_1\_TitleofWork (Example: Image\_1\_Waterfall.jpg, Image\_2\_Moon.jpg)

Video (optional):

You may submit up to two videos. Each video should be under (3) minutes in length. Video submissions should supplement, not replace or extend, the ten still images. Therefore, any video, kinetic, or time-based work referenced in a multimedia installation must be indicated by at least one still image in the sequence of ten. Omit voiceover narration, artist appearance, or artist name in

the video submission. Process documentation videos, walk-throughs or walk-arounds of static works or studio, and documentation of additional works not included in your ten still images will result in the video being removed from your application.

Video specifications:

File types accepted: mp4, mov, avi, mpg, 3gp, flv, webm, wmv, mkv, or m4v files.

Under 3 minutes in length.

Upload each video as one work sample and in the order you would like them to be viewed. Please leave ample time for the upload.

Additional PDF (optional) :

For artists' work that involves text, artist books, book spreads, didactics, or texts that are unreadable in the images submitted, there is an option to upload an additional PDF.

The PDF attachment should supplement, not replace or extend, the ten still images. Therefore, any work referenced in the PDF must be indicated by at least one still image in the sequence of ten. *For example, if you upload a photo of the center spread of a chapbook, you may include the text from the chapbook in the PDF.*

**5. Artist Statement:** Submit a current artist statement about your work (one page, 500 word limit). Do not include your name, home or studio address, phone number or e-mail address on the statement. Label and upload your file like this: Artist\_Statement.PDF

The Artist Statement should address at least one of the following questions:

What is the future direction of your work?

What will you do with the funds?

How will the fellowship benefit your practice?

Why is this a pivotal moment in your practice where receiving this fellowship will make a difference?

A strong Artist Statement **describes your artistic practice in relation to the images you are submitting and how the fellowship will affect you and your work.**

**6. Image Description List:** Applicants must include an Image Description List that corresponds to the images/video/pdf included in the application.

Label and upload your file like this: Image\_List.PDF.

Year

Medium

Dimensions (h x w x d inches)

Description: (optional) 400 character annotation describing the medium, context, or installation of a particular work. Information should provide the juror with a greater understanding of what they are viewing. Avoid personal commentary and interpreting the work for the jurors.

## VII. FAQ

Q: If I am a teaching artist at MCBA, am I eligible to apply for the McKnight Fellowship?

A: *Yes, as long as you are not MCBA staff, MCBA board member, family of MCBA staff member/board member, McKnight staff member, McKnight board member, or family member of McKnight board/staff – you are eligible to apply for the program. Teaching artists are considered contracted workers, not MCBA staff members.*

Q: I have just recently started to develop my book art skills this year. I am over 40. Am I a mid-career book artist?

A: *Mid-career does not necessarily mean mid-age. This fellowship is for book artists who have had a significant amount of achievement in their work – exhibitions, published essays, fellowships, residencies.*

Q: Should I include current artwork or a breadth of artwork?

A: *You should include your best (and most well-documented) work, but I would recommend including artwork made within the past 8-10 years.*

Q: Should I use an active voice when filling out this application? (“I will”...rather than “If I...”)

A: Yes.

Q: I applied for the McKnight Fellowship for Textile Artists 2020, but did not receive the award. Am I eligible to apply for the Fellowship for Book Artists 2020?

A: *No. You can only apply for one McKnight Fellowship per program year.*

Q: Are the jurors book artists?

A: *The jury panel is composed of artist/curators/educators who are professionals in the field of book arts.*

Q: My name is included in the title of an essay or publication that have been written about me. Should I omit this from my resume entirely?

A: *You can substitute “Artist Name” for your actual name if it is included in the title of the essay or publication.*

Q: Will image files be viewed individually, two by two, or all at once?

A: *Image files will be viewed in order individually beginning with Image 1.*

A trip to the local bookstore or camera shop, a visit to amazon.com, or an Internet search for something like "take good digital photographs" or "scanning slides" should turn up plenty of information sources.

Digital Photography: An Introduction by Tom Ang is a helpful guide to the basics of the medium. Chapters 3 and 4 are especially helpful for turning your existing images into digital files. It retails for about \$15.
